



## EU Green Deal The Role of Rail for climate targets

Transport represents almost a quarter of Europe's GHG emissions – the only sector failing to reach the objective of CO2-emissions reduction.

Rail is the exception: it is the only mode which has decreased its emissions while improving its energy efficiency.

- ➤ No climate-neutrality objective can be reached without decarbonising transport.
- > Rail is part of the solution to fulfil Europe's holistic sustainability's ambitions.
- ➤ The European rail supply industry is fully committed to a clean mobility paradigm according to the principle "affordable, sustainable mobility, for everyone, everywhere".





# Shift2Rail - a key PPP of Horizon 2020 for the competitiveness of the European rail industry



## The Rail Industry: An industry committed to research & innovation

■ The world leadership of the export-oriented rail industry is also due to its Research/Development/Innovation capacities.



■ Innovation is in the DNA of the European rail supply industry, which currently invests 3.6% of its annual turnover in RDI and has developed innovations such as high-speed trains, ERTMS (European Rail Traffic Management Systems) and automated metro systems







## European Rail Supply Industry's feedbacks on Shift2Rail

#### Shift2Rail :

- Breakthrough for Rail R&I: for the first time, **continuity and stability** of the whole rail sector's innovation efforts is fully ensured.
- Long term budget stability, over 7 years : commitment to reach the demonstration objectives;
- It improves the EU rail industry competitiveness and the role of the EU rail transport in a multi-modal context.
- It is a great **platform for cooperation**: high value added of having railway undertakings, infrastructure managers and manufacturers within same projects;
- It enables to illustrate proof of concept (through demonstrators) for policy dossiers;
- **SMEs** participation fairly high.
